- FY'25 Funding Contract with Metro We are close to signing our contract with Metro.

Other Staff Reports

Construction and Facility Management –

Damon Besspiata

Both residents are current on their rent. Our renovations are going well. The workmen are improving the flooring to make it flow flatter, it could not be leveled because of extra costs and weight added to the building. The contractor says that they may completed the flooring this week.

● REVERT — Richard Ballard

Revert currently has helped create 27 new homeowners, 5 applicants are preparing to close, 10 applicants with homes under contract and 9 Revert eligible applicants who are preapproved and are searching for a home.

- There are still 200+ applicants who have begun an application and are in various stages of the process.
- The Housing Fair event hosted at Bates CDC had a great turnout in attendance. There were 70+ attendees and 15 housing related vendors in attendance.
- The Revert staff are preparing the guidelines and marketing materials for Landbank owned properties that will be renovated and purchased by a Revert eligible buyer. More details to come.

<u>Miscellaneous</u> – Developers can apply for 10 or more Landbank property slots but the Landbank Board will only approve one property at a time. These Landbank properties can be purchased at the cost of \$1.00 if they have applied for funding through Metro. The smaller developers can apply for no more than 3 slots at a time.
